**Electronic Bids Invitation for the: *Construction Of 10 Bed Primary Hospital At Mangala-5***

1. Mangala Rural Municipality, Office of the Rural Municipal Executive has allocated funds towards the cost of *Construction Of 10 Bed Primary Hospital At Mangala-5* and intends to apply part of the funds to cover eligible payments under the Contract for *Construction Of 10 Bed Hospital At Mangala-5* and identification number MRM/NCB/WORKS/11/2077/078. Bidding is open to all eligible as per Section V of bidding document.
2. Mangala Rural Municipality invites electronic bids from eligible bidders for the construction of *Construction Of 10 Bed Primary Hospital At Mangala-5* under National Competitive Bidding – Single Stage Two Envelope Bidding procedures. Only eligible bidders with the following key qualifications should participate in this bidding:
  - Minimum Average Annual Construction Turnover of the best 3 years within the last 10 years: *Nrs. Eight Crore Sixty Five Lakh (Nrs. 8,65,00,000)*.
  - Minimum Work experience of similar size and nature: *At least 1 Building contract within last 10 year with value of at least Nrs. Eleven Crore Fifty Four Lakh (Nrs. 11,54,00,000) excluding VAT.*
  - Minimum Work experience of similar size and nature (Key Activities): *1014.20 cum of PCC for Rcc work, M20, 128.95 MT of Reinforcement steel, 365.6 Cum Of Brick works.*
3. Under the Single Stage, Two Envelope Procedure, Bidders are required to submit simultaneously two separate sealed envelopes, one containing (i) the Technical Bid and the other (ii) the Price Bid, both in turn enclosed in one sealed envelope as per the provision of ITB 21 of the Bidding Document.

5. Bidder must submit their bid electronically and download the bidding documents for e-submission from PPMO's e-GP system [www.bolpatra.gov.np/egp](http://www.bolpatra.gov.np/egp). Bidders, submitting their bid electronically, should deposit the cost of Nrs. 10,000 (Ten Thousand Rupees Only) bidding document in the Project's Rajaswa (revenue) account as specified below.

6. Pre-bid meeting shall be held at Mangala Rural Municipal Executive, Babiyachaur, At 2077/12/09, 11:30 hours.
7. Electronic bids (One Technical Bid and another Price Bid) must be submitted through PPMO's e-GP system [www.bolpatra.gov.np/egp](http://www.bolpatra.gov.np/egp) on or before **12:00 hrs on 2077/12/18**. Bids received after this deadline will be rejected.
8. The bid will be opened in the presence of Bidders' representatives who choose to attend at **14:00 hr on 2077/12/18** at the office of Mangala Rural Municipality, Babiyachaur, Myagdi. Bids must be valid for a period of **120 days** after bid opening and must be accompanied by a bid security or scanned copy of the bid security in pdf format in case of e-bid, amounting to minimum of **Nrs 31,32,000** which shall be valid for 30 days beyond the validity period of the bid.
9. If the last date of purchasing and /or submission falls on a government holiday, then the next working day shall be considered as the last date. In such case the validity period of the bid security shall remain the same as specified for the original last date of bid submission.
