## Electronic Bids Invitation for the :Construction Ranbang Health Post

- Mangala Rural Municipality, Office Of the Rural Municipal Executive has allocated funds towards the Cost of **Construction of Ranbang Health Post Building**. And intends to apply part of the funds to cover eligible payments under the Contract for MRM/NCB/WORKS/3/2078/079. Bidding is open to all eligible as per Section V of bidding document.
- Mangala Rural Municipality invites electronic bids from eligible bidders for the Construction of Ranbang Health Post Building under National Competitive Bidding – Single Stage Two Envelope Bidding procedures. Only eligible bidders with the following key qualifications should participate in this bidding:
  - Minimum Average Annual Construction Turnover of the best 3 years within the last 10 years: 15 million.
  - Minimum Work experience of similar size and nature: At least 1 Building contract within last 10 year with a value of at least 18 million excluding VAT.
  - Minimum Work experience of similar size and nature: Pcc for RCC Works(M20)= 140cum & Reinforcement steel Bar Works=17Mt
- Under the Single Stage, Two Envelope Procedure, Bidders are required to submit simultaneously two separate sealed envelopes, one containing (i) the Technical Bid and the other (ii) the Price Bid, both in turn enclosed in one sealed envelope as per the provision of ITB 21 of the Bidding Document.

Bidders, submitting their bid electronically, should deposit the cost of bidding document in the Project's Rajaswa (revenue) account as specified below .

- Pre-bid meeting shall be held at Office of Rural Municipal Executive, Babiyachaur, At **2078/07/26, 11:00 hours**.
- Electronic bids must be submitted to the office Mangala Rural Municipality, Babiyachaur, Myagdi through PPMO's e-GP system [www.bolpatra.gov.np/egp](http://www.bolpatra.gov.np/egp) before **12:00 Hrs on 2078/8/5**. Bids received after this deadline will be rejected.
- The bids will be opened in the presence of Bidders' representatives who choose to attend at **14:00 Hrs on 2078/8/5** at the office of Mangala Rural Municipality, Babiyachaur, Myagdi. Bids must be valid for a period of **90 days** after bid opening and must be accompanied by a bid security or scanned copy of the bid security in pdf format in case of e-bid, amounting to a minimum of **Nrs.5,75,000** which shall be valid for 30 days beyond the validity period of the bid.
- If the last date of purchasing and /or submission falls on a government holiday, then the next working day shall be considered as the last date. In such case the validity period of the bid security shall remain the same as specified for the original last date of bid submission.
- Other Thing not includeded in Bidding documents will be as per PPA,2063 and PPR,2064.
